

Privacy Statement

This privacy statement describes why and how IFIS collects and uses personal data of the subscribers of its newsletter (the “**Subscribers**”).

In accordance with the provisions of the EU Regulation n°2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (the “**GDPR**”) and any data protection law applicable in Luxembourg (including but not limited to the law of 1st August 2018 on the organization of the National Commission for Data Protection and the general regime on data protection, as may be amended or replaced) (collectively hereinafter the “**Data Protection Laws**”), IFIS, acting as data controller (the “**Data Controller**” of “**IFIS**”), collects, stores and processes personal data of the Subscribers for the purpose of the mailing of its newsletter, the mailing of invitations and the mailing of relevant information about ethics and integrity in the finance and business sector.

Such personal data includes the name, surname, company name and e-mail address (the “**Personal Data**”).

The Data Controller may delegate the processing of the Personal Data, in compliance and within the limits of the applicable laws and regulations, to other data recipients being:

- Third party organizations hosting or co-hosting IFIS events; and
- Third parties providing data processing or IT services to IFIS

(collectively called the “**Recipients**”).

The Recipients may, as the case may be, process the Personal Data as data processors (when processing the Personal Data upon instructions of the Data Controller), or as distinct data controllers (when processing the Personal Data for their own purposes, namely fulfilling their own legal obligations, if any in that respect).

In accordance with the conditions laid down by the Data Protection Laws, Subscribers have the right to:

- object to the processing of their Personal Data;
- request erasure of their Personal Data;
- request for restriction of the use of their Personal Data; and
- request for Personal Data portability.

The Subscribers may exercise their above rights by writing to the Data Controller at the following address: info@ifis.lu.

Personal Data shall not be retained for a period longer than necessary for the purpose of the data processing, subject to any limitation periods imposed by law, subject to statutory limitation periods.
